Scope:

The policy applies to all members of the University community including students, staff and others who work with the university on part-time bases or through a contractual agreement with a third party. The policy also applies to all of the University's operations and activities.

Responsibility:

The main responsibility for implementation of this policy lies with the University Council and the University Director. The academic and administrative branch assistants (ADAA and ADAF) are responsible for ensuring compliance with the University Environment Policy within their sector. The University will actively monitor the performance of the different sectors and departments in the implementation of the aims and objectives of this Policy in their activities and functions. All members of the University community are accountable to safeguarding the environment and are expected to fully comply with the environmental sustainability policy.

- Embed sustainability principles in all University functions and practices that aim to eliminate negative impacts on the environment.
- Promote a culture that foster sustainable innovation through education, training and research.
- Implement an environmental management system that is consistent with international standards and benchmarks.
- Establish environmental sustainability plans and identify opportunities to improve environmental sustainability.
- Comply with the relevant environmental legislation, environmental agencies' guidelines and regulatory frameworks.
- Adopt responsible on campus work practices and conservation strategies to reduce adverse environmental risks and to protect the ecosystem.

Specific details for implementation of the policy:

- To make efficient and environmentally responsible use of water and electricity, including identifying opportunities for water reuse and lowering electricity consumption.
- To implement sustainable resource management practices, based on reduce, reuse and recycle principles.
- To implement sustainable travel and transport practices across all activities with the aim of reducing the carbon footprint.
- To promote sound approaches in the procurement of goods and services and to work with suppliers who promote sustainable resource management practices.
- To develop and implement a sustainable construction strategy for the University buildings and infrastructures projects based on sound ecological designs, low carbon technologies and environmental sustainability principles.
- To promote the relevant volunteering programmes among the university students and staff including green campus and environmentally friendly initiatives.
- To raise awareness of staff and students of the University's environmental impact, activities and performance and good practice.
- To provide appropriate environmental educational programmes for staff, students and local community members.
