**CORE VALUES** 







AOU's core values govern the process of the vision and mission. As a student, it is essential that you are informed about the core values, philosophy, vision and mission of the University. The Core values on which rests the mission and vision of AOU are as follows:

**Equal Opportunities and Respect for Diversity**: all members of AOU including students and staff are provided equal opportunities and respect for diversity, irrespective of age, gender, religion, nationality, disability or socio-economic strata. Programme delivery at AOU supports equality and inclusion.

**Integrity:** all members are expected to align their decisions and actions to be consistent with the core values of AOU in a manner that demonstrates the highest commitment and is in the best interest of the university.

**Excellence:** to maintain the highest teaching and learning standards and to provide the highest standards in the teaching and learning environment.

**Student support**: AOU believes in providing all possible student support towards effective engagement and enhanced experiences. AOU values student feedback equally on aspects of teaching and learning.

**Safeguarding:** To safeguard and provide a safe working and learning environment against any kind of abuse and harassment to members of AOU especially those that are vulnerable.

**Accountability and Transparency**: AOU maintains complete transparency of information in its operations towards providing excellent teaching and learning services.

**Quality Assurance**: AOU has a robust quality assurance system for all aspects of teaching and learning of which monitoring, evaluation and reporting are important components that help AOU strive towards excellence.

### STUDENT COMMITMENT:

**Diligence:** commit oneself to diligently pursuing studies towards meeting all learning requirements

**Engagement:** commitment to attending scheduled tutorials, submission of assignments, and taking all required tests and exams. Proactively participate in any required learning activities. Utilize the AOU learning resources optimally to facilitate learning.

**Compliance:** complying with all AOU statutes policies and regulations relating to student learning and student conduct on campus. AOU student terms and conditions (provided in this booklet) clearly state student expectations.

Personal conduct: students are expected to agree to the student charter on joining AOU and this includes maintaining high standards of personal conduct and respecting others. It is important that as a student you need to engage in mutually respectful behaviour including facilitating an inclusive environment where no student is discriminated against, abused or victimized in any form due to disability, gender, nationality, age, socioeconomic strata or any other factor.

Academic Life: students are expected to take responsibility for their own learning, time management, and choices about the programme, study and assessment. This includes familiarizing oneself with the requirements to complete a programme and working towards the same in consultation with the academic advisor. The student must at all times steer clear from indulging in plagiarized work in the assignments given.

**Accountability:** at all times a student must be accountable for the decisions they take on their own that may in any way affect their learning. Students must keep the tutors well informed of absences from class or exams to receive appropriate support.

**Feedback:** you must proactively participate in providing the University with your feedback through all official channels designated. The online student survey gives students the platform to provide anonymous feedback, which the student may utilize to give honest and unbiased feedback to improve the teaching and learning environment.

**Being informed:** all students are expected to have read the University information that clearly pertains to student information that should empower students to be directed appropriately

Safety and Wellbeing: The health, safety and well-being of those within the AOU community is of great importance to AOU. All members of the AOU community are expected to comply with health protocol and abide by safety rules. The students are to promptly report all accidents and wellbeing concerns to the safeguarding Officer at the branch who will provide requisite support.

# AOU STUDENT TERMS AND CONDITIONS:

Attend all facilitating learning activities such as tutorials, seminars, online activities, and laboratory classes as specified in your programme of study.

To comply with the University's requirement of undertaking assessments in compliance with the University rules and regulations.

Make appropriate use of resources available to facilitate your programme as E-Library facilities, use of LMS etc.

Act with academic integrity in all aspects of your studies as avoiding plagiarism and evidencing your work accurately and honestly.

Comply with the student's code of conduct and maintain the required student decorum.

Be aware of the information provided about the University and your programme and the policies that govern the University's teaching and learning environment.

Cooperate with fellow students and teaching and non-teaching staff on campus.

Check regularly the University communication on your University e-mail and Learning Management System.

Students must pay complete registration charges, course fees and any additional charges towards services by the stipulated cutoff date in order to continue with their programme.

Students must not have any over-due payment beyond the time permitted by AOU.

In case of a third party paying the fees on your behalf, the student will continue to be liable to ensure payment, failing which the student the consequence will be borne by the student.

Nonpayment of fees or until all outstanding fees are paid the University reserves all right to take necessary action against student continuation in the programme as suspension, withholding or terminating.
